3098 Minutes of the last meeting

Agreed that the minutes of the meeting held on 10th January, 2007 be signed as a true and correct record

3099 Report of the Clerk

i. Annual Parish Council Meeting (not Annual Parish Meeting) – the clerk reported that this would take place on Thursday, 10th May, 2007 as this was the only date within the time frame allowed following an election when the village hall was available.

3072 Finance

3073 Correspondence and Items for Information

i. Letter from Royal British Legion – thanking the council for the work undertaken on the War Memorial. They would like to change gate to a more

elaborate gate which they will pay for to commemorate their late president Dr Crittendon

Agreed to support the Royal British Legion proposal for a commemorative gate. It would be appreciated if the design could be presented to the council before the work is begun. Some councillors expressed a preference for a wooden gate, but it was felt the final decision should be left to the Royal British Legion

ii. Central Networks Home Safety Pack – Central Networks have issued a home safety pack to all parish councils asking them to make their residents aware of the basics which ought to be kept in any house in case of a power cut Agreed that the clerk should forward the details and pack to the Wednesday Club

Agreed the clerk would include an item in the parish magazine

Power cuts – concern has been expressed about two recent power cuts in
parts of the village which last for 40 hours in total with just a four hour break in
the middle. The major problem was that when a telephone call was made to the
electricity company there was only a recorded message acknowledging the
problem which was not updated to keep residents informed
Agreed the clerk to contact Central Networks regarding this problem to get
their comments on the situation

iii. Community Council of Staffs – The Last Post – event to highlight proposed changes to rural post office services on 1st March, 2007, 9.30 am to 1.00 pm. Agreed only the clerk will attend

3074 Parish Web Site

- i. Business Listing The clerk has only received one response to the article in the parish magazine for anyone running a business in Kings Bromley who would like a free listing to contact her Agreed that Cllrs Browne and Pritchard would deliver fliers provided by the clerk to the industrial units at Woodgate and Archers respectively
- ii. Village Hall Information and Photographs Cllrs Browne and Mrs Jarman were reminded of their undertaking to provide information on the Village Hall and village photographs respectively
- iii. Footpaths

Agreed that as the existing village walks leaflets needed some revision that nothing would be included on footpaths at present

3075 War Memorial

- i. **Update on stonework** Cllr Pritchard has spoken to the stone mason and stressed the importance of completing this work before the end of March
- ii. Maintenance of War Memorial flower borders post renovation the Gardening Guild have been unable to find a volunteer to look after the border surrounding the War Memorial Agreed that a letter be sent to Mr Jarman asking him if he would be happy to
- keep the border neat and tidy

 iii. Insurance of War Memorial this will be done when the stonework is completed

3076 Village Shop

Meeting with Community Council/ Village Shops Retail Shops Association

 this meeting for parish councillors will take place on Thursday, 22nd February,
 2007 at 7.30 pm at the Village Hall

3077 Noticeboards

- i. **Presentation of O2 Award** this will take place on Thursday, 8th February, 2007 at 4.00 pm at the Village Hall
- ii. Press Release the press release prepared by O2 and circulated to councillors was noted
- **iii. Grants** the Horticultural Society are prepared to make a grant of £1,000 towards the replacement of the noticeboards, if the parish council undertakes the repair of the map board in front of the Village Hall. This noticeboard is covered by the parish council insurance
 - **Agreed** that the parish council accept this very generous offer from the Horticultural Society and undertake the repairs of the other noticeboard
- iv. Quotations for Replacement the report prepared by the clerk detailing the two quotes for was considered

Agreed that a new 8 page noticeboard for the school, two 18 page noticeboards to go by the War Memorial and on the Village Hall frontage and a frame for the village map on No. 1 Lichfield Road would be purchased from Signs 1st at a total cost of £3,555

Agreed the clerk to write to the school headmaster outlining the costs of the school board and explaining that it could not be part funded from SCC monies, so is now going to cost the parish council more than anticipated, and make the request for any financial help towards the noticeboard

Agreed to ask the school to consider having the aluminium case inside the oak doors as the parish council feels that this would be by far the best value for money and provide a board which will last for many years

Agreed the clerk to liaise with Signs 1st to try to trim the installation costs if all the boards are purchard

Agreed that the map on No. 1 Lichfield Road would be the existing map reused To date grants of £700, £400, £300, £1,000 and £100 have been received from SCC, O2, Community Council of Staffordshire, the Horticultural Society and the BKV prize money, giving a short fall on the total project of ££1,055

Agreed that a maximum of £1,500 be taken from parish council reserves to complete the funding of this project (Proposed by Cllr Browne, seconded by Cllr Mrs Jarman)

Agreed the clerk would look at earmarked reserves left at the end of the previous financial year to see if any would no longer be required and could be directed towards this project

3078 Trees

- i. **Inspection report on trees** the contents of Mr Helliwell's report were noted
- ii. Quotations for tree works the report of the clerk tabled at the meeting detailing three quotations for the work was considered Agreed that the work should be undertaken by James Tonks of Shenstone Agreed that Cllr Pritchard would check with LDC whether the one tree identified for removal had any tree preservation order on it.

3079 Footpaths

i. Grant Aided Leaflet – the clerk reported that the walk leaflet she had checked contained some inaccuracies which needed to be resolved before any reprint could be done. The other three walks had not been checked. The original budget for the project was only £250

Agreed that the project should not proceed as the costs including designing the leaflet and printing would exceed the original budget considerably

ii. Crawley Lane Footpath – the clerk will report this to SCC for them to look at

3080 Access across parish council land to rear of the Hollies

The comments of letters from local residents on whether an access over parish council land in Leofric Close should be granted were detailed in a report circulated prior to the meeting and a report tabled at the meeting. The overwhelming view of the residents was that a right of access should not be granted. The council had received advice from NALC through the SPCA

Agreed that after serious debate and a great dealt of consultation within the parish the council does not accept the financial offer made and grant a right of access across its land in Leofric Close (Proposed Cllr Mrs Jarman, seconded Cllr Taylor). There were two abstentions due to interests declared and everyone else was in favour

3081 Parish Plan Quarterly Review

Agreed to carry this forward to the next meeting

3082 Beech Avenue Bench

The clerk reported on one quotation received for the repair of this bench at £490. **Agreed** that Cllr Pritchard would obtain a second quotation for the work

3083 Royal Oak Public House

The chairman reported on an approach made to him by the landlord of the Royal Oak.

The brewery is concerned that not enough beer is being sold and it would like to see darts and other activities introduced. The landlord does not wish to follow this course of action and would like to buy the pub so that he can maintain it as a gastro pub. As a contribution towards the funds for this project he would like to sell off land at the back of the pub (not the car park) and convert garage to bakery/shop/post office, but he would not want to run such a business venture.

Agreed that this was not a matter for the parish council unless a planning application is submitted to LDC

The clerk reported that the Village Shops Retail Association did ask if there was any other premises in the village
