# Minutes of the Parish Council Meeting held on Wednesday, 3<sup>rd</sup> October, 2007, at 7.45 pm in Kings Bromley Village Hall

There were 6 members of the public at the meeting

Mrs Piggott reported on the school's World Wise Club, which has a link with a school in Thailand, including writing projects and web chats.

On Rugeley Road from junction with A515 on the quarry side the trees on the other side of the wall are overhang the verge, making it impassable for pedestrians

There are problems on river on the bypass between the two lakes between Mill House and the main Trent, with trees falling into the river obstructing water flow on the opposite side to Bromley Hall

On the Strawberry fields there is an oak tree with two dangerous branches. Cllr Holland has spoken to Mr Baskerville who acknowledges that the tree is partially dead. It is not clear whether the tree is on Mr Flint's or Mr Baskerville's land, but Mr Baskerville has agreed to attend to the tree after checking that there is no preservation order on the tree Royal Oak Pub application – the village needs a pub and any improvements which can be made to the pub should be welcomed

- Rugeley Road Verge trees from behind the wall overhand the verge on the xi. Rugeley Road, making it impassable for pedestrians Agreed the clerk will write to the new owners of the guarry
- xii. River between main Trent and Mill House trees have fallen into the far side of the river on the link between the two lakes which is impeding the water flow. Agreed that the clerk will write to both the Environment Agency and the new owners of the quarry
- xiii. Email from Mr Mulholland to Cllr Pritchard Mr Mullholland gave permission for Cllr Pritchard to share the contents with the whole parish council. Mr

Mulholland is making the council aware that around 30 tonne of soil has been piled up against the Manor Wall, and this could do damage if left there on a long term basis. It is against the wall between Mr Cooper and Mr Mulholland. Mr Mulholland believes that the parish council should consider this matter as the village has considerable interest in this wall. From Bromley Hall, it is possible to see the damage which is being done to the wall, where it is coming through the wall because it cannot breathe. It would appear that the pile of soil is to be used for landscaping in the future. The owner of the soil has said that he will not allow the wall to be damaged.

**Agreed** to contact the Conservation Officer at LDC to draw their attention to this problem as it appears to be unacceptable in the Conservation Area **Agreed** the chairman will speak to Mr Cooper regarding the soil adjacent to the wall and ask for it to be moved to allow circulation of air around the wall

#### 3297 Noticeboards

The clerk reported that she is Signs 1<sup>st</sup> are not returning calls when promising to do so or carrying out the work as agreed and she is continuing to try to contact them

# 3298 Village Shop Questionnaire

The recording of the findings of the questionnaire is still ongoing and should be completed by the November meeting. The clerk reported on discussions with Mrs Pat Hudson of ViRSA, who indicated that a small sum of money is available to pay for the recording of the questionnaire information if required. She would also be happy to meet with just one or two people who have an interest in helping to run a shop, to discuss what's involved. She also suggested that if accommodation is a problem, could a mobile building be used, which limits the initial capital outlay whilst giving time to see if a shop is viable

#### 3299 Kings Bromley Conservation Area

The new draft of the Kings Bromley Conservation Area Appraisal from LDC was considered.

**Agreed** the council is happy for the Conservation Area to be extended, particularly to include Manor Park Nurseries, but that part of the boundary does not seem very logical in places, as it appears to zig zag rather a great deal. The council would also like the boundary in front of Bromley Hall to be revised as there are several significant trees within the grounds of Bromley Hall.

Agreed to inform LDC of the discrepancies with regards to 13 Manor Road

### 3300 Footpaths and Verges

- i. Overhanging hedges and shrubs there is a tree in the garden of No, 14 The Grange which overhangs the footpath badly
  - **Agreed** the clerk will write to the owner of No. 14 The Grange and ask for the tree to be cut back to allow unhindered access to the footpath
- ii. **Strawberry field** Cllr Holland reported that the entrance to the field is becoming something of a mess where the traffic goes through. Mr Baskerville has agreed to speak to the users of the field regarding the problem and the waymarking of the public footpath
- iii. Old road down to Yoxall Bridge this has not appeared on any maintenance schedule to date, but SCC will now arrange for vegetation to be cut back within the next month and try to get the gate post repaired too.
- iv. **Chamberlain Close verge** the clerk has reported this to both SCC and HomeZone. No reply has been received from HomeZone, but SCC are going to

try to ensure that next time it is cut, it is cut to a much better standard, although the quality of the verge is poor to begin with
