During the night Monday evening/Tuesday morning it was reported that workmen were working on the sewer opposite the bus stop at the top of Alrewas Road. There have been reports of sewage running behind the cottages 2 to 10 Alrewas Road. No further details are known or have been confirmed. It has been noted that there have been some problems with the pumping station on Yoxall Road

A newspaper report a couple of weeks ago detailed plans to increase gravel workings in the wider area which would increase the amount of HCV traffic going through Kings Bromley

The tip at Lichfield is now closed on Mondays and Tuesdays, could this not have been notified to residents in advance. Cllr Pritchard will discuss this with Cllr Mrs Eagland

The existing parish council publication scheme was approved in 2002 and expired in 2007. The Information Commissioner extended all schemes until the end of 2008 – but did not bother to inform anyone. The model which has been circulated is a consultation draft between the Local Government Association and County Associations to discuss, not for parish councils unless they particularly want to add anything

She expressed concern at the cost of the event and the need for the provision of lunch – which she will not be taking – given the financial constraints currently facing Social Services
