Notice of traffic management on Shaw Lane near Hanch, Lichfield

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons. Please note that the times and dates in this notification are subject to change.

There will be a temporary traffic management

There will a road closure followed by traffic lights in place on Shaw Lane and a small section of Tuppenhurst Lane **in two phases** from **Monday 12 April**, following similar works in 2020. This is to allow safe access to our work sites to prepare for future construction works, which include roadside vegetation clearance as well as archaeological site access.

- Phase 1: Temporary road closure on Shaw Lane and Tuppenhurst Lane, **12 April for two weeks, 9:30am-3:30pm**
- Phase 2: Temporary traffic lights on Shaw Lane, **26 April for three weeks, 8:00am-5:00pm**

Our teams may be on site up to site one hour before and one hour after the works to set up and secure the site at the end of each day.

While this closure is operational a signed diversion route will be in place. Please see the map overleaf for more information. Access to properties and businesses will be maintained while these works progress.

We're uncovering Britain's past

Before we begin to build the new railway, the surrounding area will become part of the largest archaeology programme ever undertaken in the UK.

We will be carrying out archaeological trial trenching and trial pitting work on land off Shaw Lane. This work is due to start from Monday 19th April for around four weeks (subject to weather and site conditions).

A team of archaeologists will be working on the site to excavate trial trenches and pits. Machinery will be used to remove the topsoil before archaeologists dig by hand and carefully record any findings.

Temporary road closure on Shaw Lane and Tuppenhurst Lane and use of a diversion, followed by traffic lights on Shaw Lane.


What we will do

Keep all sites safe and secure, while keeping disruption to a minimum.


Ensure all traffic management is clearly signed.
