The work we are doing

We will be carrying out utility trial trenching, along Wood End Lane, which will involve digging into the ground to establish what is underneath the surface. This will provide us with information on the location of underground utilities, which we need to assess as we develop our construction plans.

For the work to be completed in a safe environment, we will be temporary lane closures of Wood End Lane.

When will we undertake these works

From June 21 – 2 July for 10 days

Our working hours will be 9:30am to 3:30pm.

Our workforce can be on site one hour before and after to set up and take our work equipment.

There will be temporary traffic lights on Wood End Lane, and Watery Lane.

There will be no weekend working.

Businesses will be open as usual.


