



# Notice of traffic management on Wood End Lane, Fradley

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we are doing

We will be installing temporary traffic lights and lane closures for a length of 200m in five locations, on Wood End Lane. This is to allow us to safely carry out the installation of signage, to highlight works access points and provide advance warning of works traffic.

## When will these works take place

Our works will commence on Monday 23 May, for a two week duration.

Our working hours will be from 8am until 6pm Monday to Friday. Access to properties will always be maintained. Our workforce can be on site one hour before and after to set up and secure our equipment.

## Where we will be working

We will be installing temporary traffic lights in five locations, highlighted on the map below. We will install the signage at one location at a time, moving onto the next location once complete. We expect the programme of works to be completed within two weeks.
