



# Notice to extend temporary road closure on Shaw Lane, Hanch

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## What we are doing

As part of our preparatory works and for the safety of the public we have installed a temporary closure to a section of Shaw Lane, detailed on the map below. This is to support the construction of a new site compound and works access points on Shaw Lane, connecting our existing haul roads.

## When the closure will take place

Shaw Lane has been closed since Monday 13 June and was due to reopen on Friday 9 September 2022. Unfortunately, our works on Shaw Lane have been delayed due to ecological constraints and we will need to extend this closure for another three weeks.

## Where will we be working

Our construction vehicles will use our existing haul roads to access our working areas from the A515.
