



# Updated notice of overnight closures on A38 at Streethay

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

You have previously been informed of overnight carriageway closures on the A38 at Streethay. Due to unforeseen circumstances, we are rescheduling our northbound closure. Details of which are below.

To ensure the safety of road users, we are required to undertake essential maintenance activities on the main A38 carriageway. To allow us to complete this work, we will be installing overnight closures on the A38 northbound and southbound carriageways at Streethay, including both slip roads. Following the reopening of the carriageways, the northbound slip road will reopen and the southbound slip road will remain closed.

Our work within the Streethay area of Lichfield include piling and utility diversions on both sides of the A38.

## When the work will take place

We will be installing the following overnight closures:

- **Rescheduled northbound closure: 12 December 2022**
- Southbound: 10 December 2022 and 17 December 2022

The carriageway will close from 9pm each evening and reopen at 5am, before rush hour. At the point of reopening, a speed limit of 40 mph will remain in place, along with narrow lanes.

Whilst closures are in place, clear diversions and signage will be displayed along the route for road users. Diversion routes are provided on the following page. During our closures, you will not be able to access A38 via Streethay or exit at Streethay.

## Duration of works

Rescheduled overnight **northbound** carriageway closure:

- 12 December 2022

Overnight **southbound** carriageway closures:

- 10 December 2022
- 17 December 2022

All closures will be between the hours of 9pm and 5am.

We may be on site up to one hour before and after to set up and secure equipment.

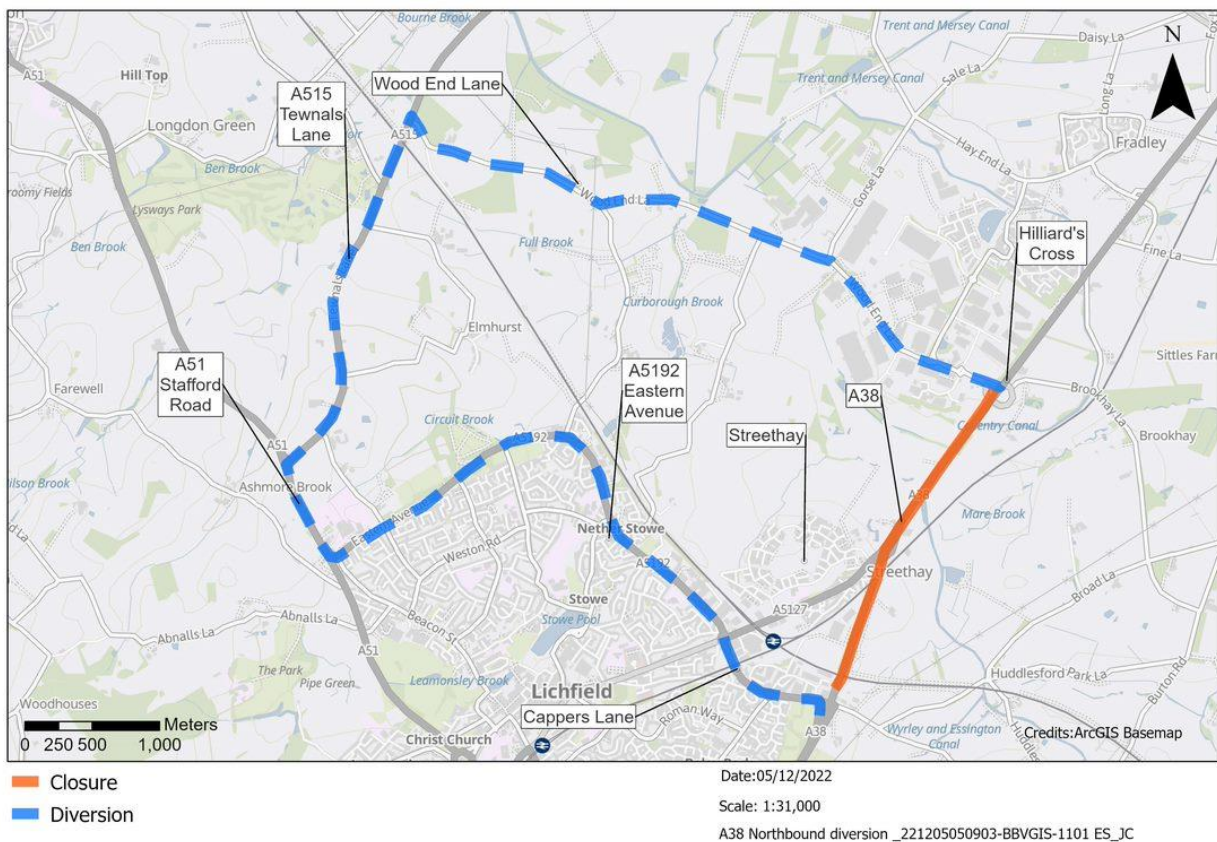

## Map of northbound overnight closures and diversion route

The map below details the **A38 overnight northbound rescheduled closure** and diversion route that will be in place on 12 December 2022.

**Northbound diversion:** traffic will be diverted off at Cappers Lane, along A5192 Eastern Avenue, A51 Stafford Road, A515 Tewnals Lane, along Wood End Lane and back onto the A38 at Hilliard's Cross.



Whilst these closures are in place, you will not be able to access the A38 via Streethay or exit at Streethay. Do not follow sat navs whilst closures are in place. Please follow the signed diversion routes.

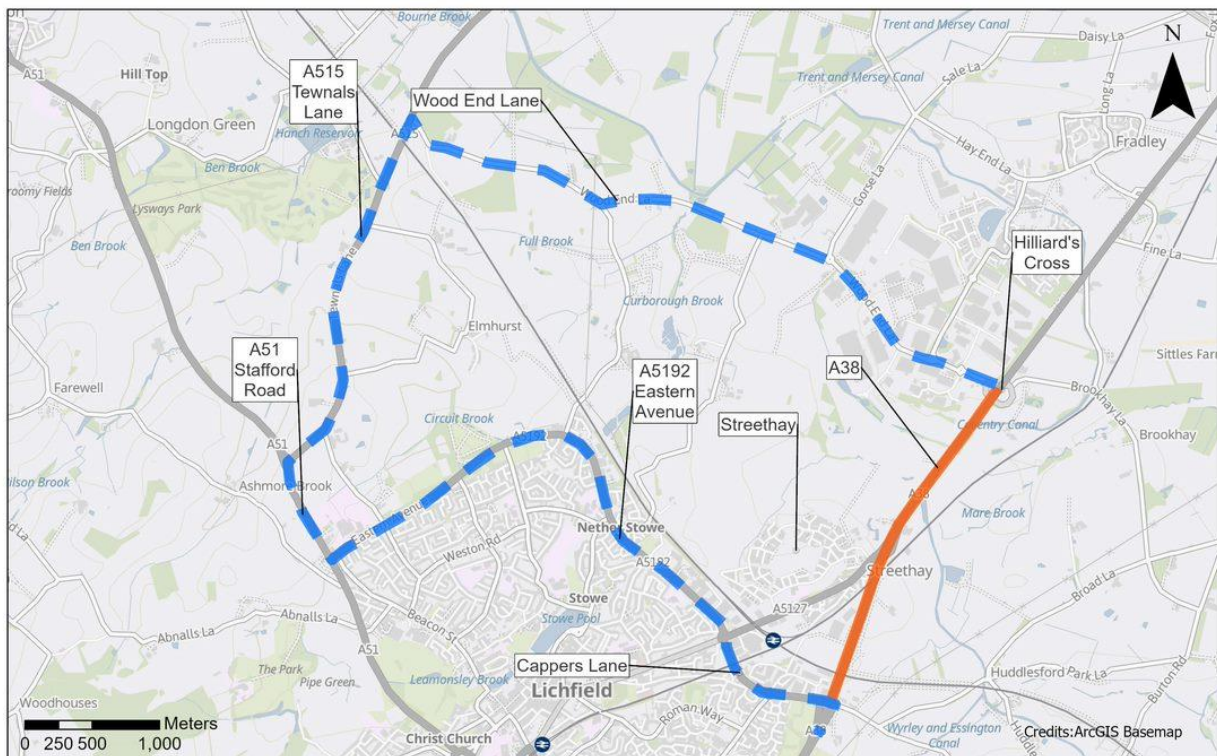

- 10 December 2022
- 17 December 2022

**Southbound diversion:** Traffic will be diverted from Hilliard's Cross, along Wood End Lane, A515 Tewnals Lane, A51 Stafford Road, A5192 Eastern Avenue and onto Cappers Lane.
