



# Notice of traffic management on Wood End Lane, Fradley

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

We will be working along Wood End Lane to create a safe access to our working area. As part of these works we will also clear a small section of vegetation and undertake trial hole surveys. To undertake these works safely we will install temporary traffic lights on Wood End Lane.

## When the work will take place

The works will take place in **two phases**.

For the **first phase** we will install temporary traffic lights from Monday 3 April to Thursday 6 April 2023. Our working hours will be from 9:30am to 3:30pm each day.

For the **second phase** we will install temporary traffic lights from Tuesday 11 April to Saturday 22 April 2023. Our working hours will be 8am to 6pm (Mon-Fri) and 8am to 1pm (Sat). For us to complete this phase of work safely, the traffic lights will remain for 24 hours a day.

Our workforce may be on-site up one hour before and after to set up and secure our equipment.

### Duration of works

Phase 1-

- Temporary traffic lights from Monday 3 April to Thursday 6 April 2023
- Our working hours will be from 9:30am to 3:30pm

Phase 2-

- Temporary traffic lights from Tuesday 11 April to Saturday 22 April 2023
- Traffic lights will be in place 24 hours a day
- Our working hours will be 8am to 6pm (Mon-Fri) and 8am to 1pm (Sat)

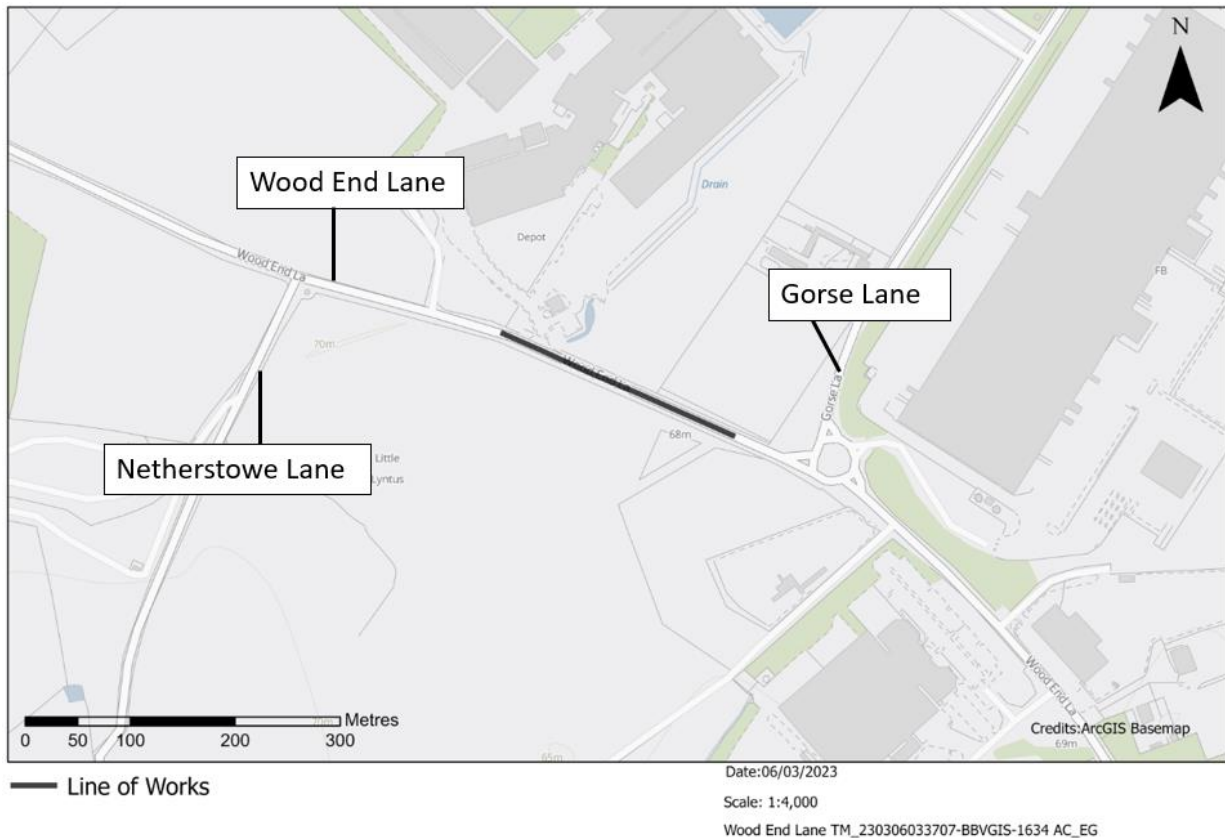

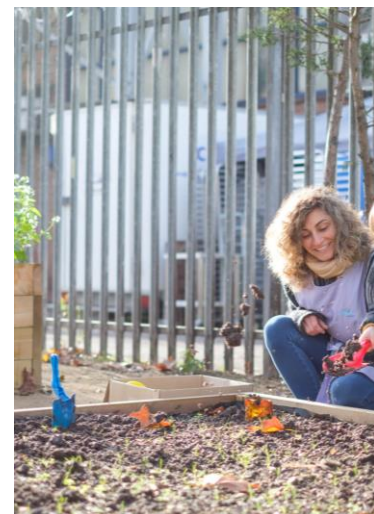
## About our Community and Business Funds
