## **UPDATED: Notice of traffic** management on Wood End Lane, **Fradley**

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be doing

We will be working along Wood End Lane to create a safe access to our working area. As part of these works we will also clear a small section of vegetation and undertake trial hole surveys. To undertake these works safely we will install temporary traffic lights on Wood End Lane.

### When the work will take place

The works will take place in **two phases**.

For the **first phase** we will install temporary traffic lights from Monday 3 April to Thursday 6 April 2023. Our working hours will be from 9:30am to 3:30pm each day.

UPDATE: The second phase of these works will be re-scheduled. We will send out further communications once the dates have been confirmed.

Our workforce may be on-site up one hour before and after to set up and secure our equipment.


