High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

Extending the temporary A38 southbound slip road closure at Streethay

In August 2022 we communicated that we would close the A38 southbound slip road to undertake works on the southbound slip road overbridge. In March 2023 the Government updated Parliament on their transport capital investment programme including an update on the HS2 project. As a result of this announcement, we have reviewed our programme with HS2 to agree which key construction work will continue and which works will be paused for two years.

As a result of the programme review and additional utility and design requirements we will need to extend the temporary closure of the A38 southbound slip road closure, at Streethay, until Spring 2024.

We will share further updates, in early 2024, on the temporary diversion of the A38 and closure of the northbound slip road.

A38 Update

The temporary closure of the A38 southbound slip-road, at Streethay, will be extended until Spring 2024.

The Fradley and Streethay 6 Public Right of Way (PRow) temporary diversion will open while works are paused at this location.

What to expect

We may need to extend our working hours as we complete works on the A38.

Some noise and vibration from the work we are completing, including piling.

Clearly signed diversion route. Please do not follow Sat Navs.

The map below details the A38 southbound slip road closure and diversion route.

During the closure, clear signage will be in place along the diversion route for road users.

This diversion will affect road users travelling into Streethay and parts of north Lichfield who would usually use the A38 southbound slip road to the A5127. The diversion will take road users to the next exit at Swinfen Island. Please do not use Sat Navs but instead follow the signed diversion.

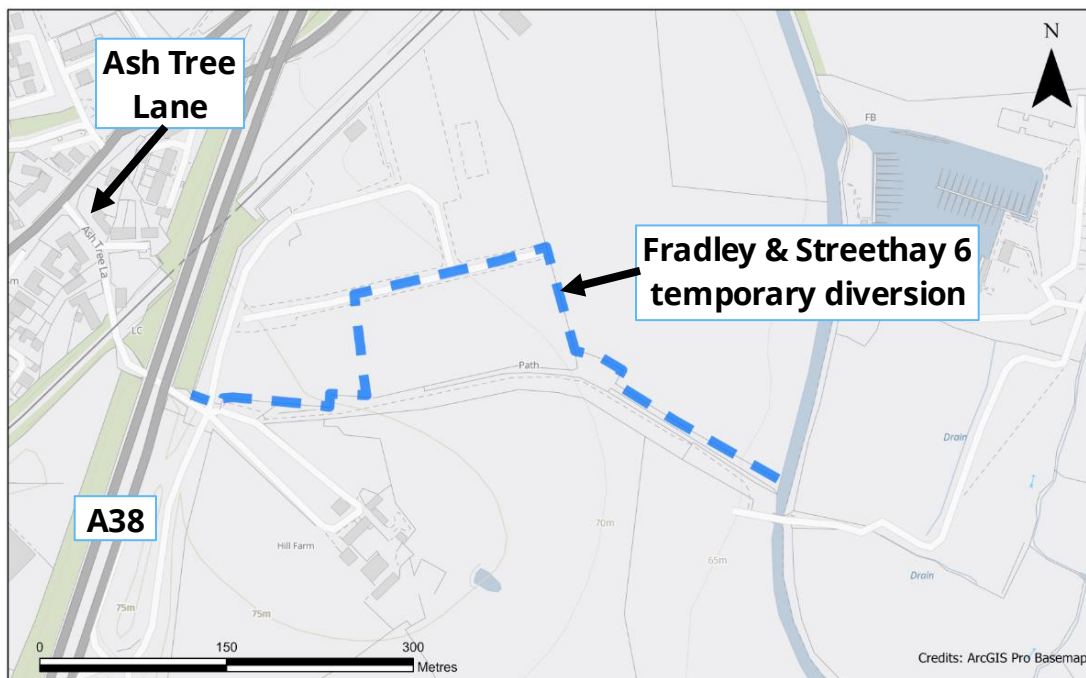
Temporary re-opening of Fradley and Streethay 6 Public Right of Way (PRow)

In April 2022 we communicated that we had commenced work on Streethay Cutting. To ensure the safety of the public we closed Public Right of Way Fradley and Streethay 6 for the duration of our construction period.

Over this period, we received feedback from the local community that this footpath enabled walkers to access Streethay, the canal and Whittington. Local residents asked us to review the closure of the footpath, as our works progressed, to assess if it could be diverted and temporarily re-opened in advance of the new Streethay Footpath Overbridge being constructed. We have undertaken a review following the Government announcement in March 2023 and have temporarily paused works on Streethay Cutting. This will enable us to create a temporary path through our site to enable the footpath to re-open. We will share an update once the new diverted footpath is created and safe to open.

Please note: We will continue to review this footpath diversion, as and when works are planned to continue on Streethay Cutting. We will keep you updated on this via www.hs2.org.uk/staffordshire
