The above application was discussed at length at the parish council meeting on 8th June. The council strongly objects to the proposal to either install a mobile home or sectional prefabricated building at the applicant's address. This is a conservation area and is not in keeping with other buildings in the area. It does not fit within the street scene. The development will be clearly visible from the main Alrewas Road, village hall and other nearby surrounding dwellings in particular 32 Leofric Close. There is also concerns about access to the main A513 and that this development may well set a precedent for others to follow. It is felt that the proposal constitutes 'in-fill' development and would be seen to create overcrowding in this pleasant residential area.

b) 23/00595/FUH – Ivy Cottage, Lichfield Road. The chairman intimated that he would view this application but felt there would be no issues and will report back.

c) 23/00616/FUL - Land To South of Manor Park, Kings Bromley. No comments.

On (c) above the clerk was asked to make the following comments to LDC. “The parish council is concerned that by varying this condition the applicant is opening up the way for boat owners to use the moorings as a permanent residence. It feels that this could increase pressure on local services such as the doctors. The reference to a register appears to be a loophole and a way to circumnavigate the residency restriction. How will the District Council control this? The parish council therefore objects to the application.”

On (d) above the clerk was asked to make the following comments to LDC. “The parish council is aware that this application has been refused by the Inspector, however, if the applicant now reverts to the original application which was granted, the council’s concerns remain as before. In particular it is concerned about the access to the site as it involves

making an entrance onto the A515, a road that has a 60mph limit. The council feels that this limit should be reduced otherwise another serious road accident will occur.”

A member of the public then spoke about an application that went before the council at the last meeting (23/00751/FUL ). He explained that he has raised issues with LDC particularly over access to the main road and the very dangerous traffic speeding issues and apologised for not attending the meeting to make his points. Cllr. Marshall said that the application will go to the LDC full Planning Committee.
